THAD EURE "Mr. ELK of North Carolina"

On the evening of May 31st, 1940, Raleigh Lodge No. 735 of the Benevolent and Protective Order of Elks was instituted.

In the Charter Class that evening was a young man that was most interested in all the proceedings. He was quietly absorbing all of the initiatory ceremony, and by the time the evening was over, the future "Mr. ELK of North Carolina" was born.

"Mr. ELK" is, of course, none other than our genial and well loved Secretary of State, Thad Eure. There is no more dedicated Elk in North Carolina, and no one more deserving of the title, "Mr. ELK."

For more than 30 years Thad Eure has preached, practiced and lived Elkdom. He has attended more State Conventions than any other Elk in North Carolina. He attends all of the District Deputy Clinics, and is always on call for any special meetings. If it is anything that will further the cause of Elkdom, Thad will be there. He has attended all of the Grand Lodge Sessions since he became Exalted Ruler of his own lodge. He has been honored by the Raleigh Lodge, the State Association and by the Grand Lodge.

1969-1987 Special Deputy Grand Exalted Ruler (Emeritus)

At the North Carolina State Elks Association Convention held in Wilmington, May 16-17, 1986, the following resolution was passed.

WHEREAS Thad Eure became an Elk in 1940 when the Raleigh Lodge was instituted; that he held office from the first year of his membership and beame Exalted Ruler in 1945; that he was one of the organizers of the North Carolina State Elks Association and actually did its charter; that he served as its President and has served continuously on State committees from the time it formed; that he was the Grand Esteemed Loyal Knight and has served on many Grand Lodge Committees; that he served as a member of the Grand Forum and its Chief Justice the last year of his service; that he was District Deputy Grand Exalted Ruler, and has served as a Special Deputy Grand Exalted Ruler, for many years; that Thad Eure has been on call twenty-four hours per day for advice, consultation and guidance to each subordinate Lodge, to the district of the State, to the State Association, to our sponsors and to the Grand Lodge; that he has interceded on behalf of our organizations with State and Federal Governments and has given unselfishly of his time, energy and resources; that he has supported the officers and members of each subordinate Lodge and the State Association; that he, without complaint, has given unselfishly of his time, energy and resources to the furtherance of the ideals of this great organization, charity, justice and brotherly love, and has always been faithful to the cause; and

WHEREAS for the first time in its history, the North Carolina State Elks Association, Inc., unanimously voted at the Fall Convention in Asheville, to honor one of its members by dedicating a convention to him, and that member being Thad Eure; and

WHEREAS in order to further honor this great Elk. this convention, earlier in its business session, voted to name its "Distinguished Service Award" in his honor, and henceforth this award will be known as "The Thad Eure Distinguished Service Award:

BE IT FURTHER RESOLVED:

That every person attending here convey to the Honorable Thad Eure our sincere appreciation for exemplifying faithfully the virtues of charity, justice and brotherly love, and to express to him, and to his lovely wife, Minta, our thanks for the thousands and thousands of hours he has given, without complaint, to the Lodges of the State, this Association and to the Grand Lodge of the Benevolent & Protective Order Of Elks; and

BE IT FURTHER AND FINALLY RESOLVED:

That a copy of this resolution be attached to the plaque to be received by the first recipient of "The Thad Eure Distinguished Service Award" and that the Secretary of this Association send a copy of this resolution to Thad Eure.

Is he not indeed "MR ELK?"

ARTHUR A. RUFFIN RETIRES AS STATE ASSOCIATION SECRETARY

In the spring of 1970, Arthur A. Ruffin (or "Double A" as he is called by many of his friends), retired from the office of Secretary of the North Carolina State Elks Association. When his brother-in-law, Ed. W. Davis, then Secretary of the Association, died in office, Arthur was persuaded to take over temporarily until a suitable Secretary could be found. Twenty five years later he was still serving a Secretary.

The lodges of North Carolina had always been treated like "step-children" when it came to the allotment of rooms at the Grand Lodge Conventions, until Arthucame along. He knew hotel people and the right person to approach, and from the time that he took over, our hotel accommodations were always something special.

And when it came time for the Grand Lodge Convention, about the first person you would meet in the lobby of the North Carolina Headquarters Hotel would be Arthur, ready to help you in any way possible. He smoothed the way for many a new Exalted Ruler attending a Grand Lodge session for the first time.

Arthur won many Grand Lodge Awards for the North Carolina Bulletin, which was put out twice a year, after the Annual and Fall Conventions. For more than 25 years Arthur served the Association excellently, and could always give sound advice. We have lost a good man when he decided to retire.

At the State Association Meeting in Durham, May 8-9, 1970, the following resolution was passed:

- Sec. 3. That a copy of this resolution be spread upon the minutes of this meeting and that a copy be furnished Brother Ruffin.

A MEMORIAL TO GUY C. KILLIAN, STATE ASSOCIATION TREASURER

North Carolina lost one of its very finest Elks, when Guy Killian, State Association Treasurer for more than Twenty-five years passed away. His handling of the financial affairs of the State Association was always on the highest level. His reports were concise and complete, and the Association always knew just where it stood in the financial picture. Guy was a family man . . . a good husband, a fine father, a delightful companion . . . in fact, you just about run out of superlatives when you started talking about him. His life history, however, can be summed up in five short, simple words: "He was a GOOD man!"

At the Fall Meeting of the State Association in Shelby, on October 3, 1970, the following resolution was passed:

WHEREAS, since the last meeting of the North Carolina State Elks Association, The Elks of the state became profoundly grieved at the passing of our Brother, Guy C. Killian, Treasurer of the State Association; and

WHEREAS, our Brother served faithfully and continuously as Treasurer of the Association for a quarter of a century until his passing away this last July, and during this period he seldom missed attending a District Deputy Clinic, always attending State Association meetings and frequently attending Grand Lodge sessions. In practically all instances, his wife, whom he affectionately referred to as "Miss Annie" accompanied him, and their devotion to each other made an indelible impression upon all those who observed them; and

WHEREAS, Brother Killian at all times faithfully and accurately accounted for the monies of the Association in such an excellent manner that no issue ever arose with respect thereto; and

WHEREAS, Brother Killian's dedication, devotion and services to the Order will long be remembered with grateful appreciation,

NOW, THEREFORE, be it resolved by the North Carolina State Elks Association, assembled in its Fall Meeting:

Sec. 1. That the Association expresses its appreciation for the life and service rendered by Brother Guy C. Killian as herein set out and recognizes its great loss in his passing.

A MEMORIAL TO RAYMOND FUSON, PAST STATE ASSOCIATION PRESIDENT

Raymond Fuson was a Past State President who distinguished himself with dedication, loyalty and ability warranting special recognition. The State Association remembers that Brother Fuson spent untold time in compiling the only History available of the Elks in North Carolina. His contributions to the State Association, and to the Order of Elks general are inscribed in the hearts of our brothers as perpetual memorials to themselves.

As Editor of the first edition of the "History of Elks in North Carolina", he had it printed and presented it to the members in 1971. This information was obtained by him, from his old Elks files, where he had preserved all his correspondence since 1938, and had a complete file of the minutes of the State Association from 1950 to 1970. He had been active in Elkdom for more than 40 years. Other information he received from the Grand Lodge Secretary's office, subordinate Lodge Secretaries and Brothers throughout the State.

The New Bern Lodge No.764 elected him Exalted Ruler in 1939-1940. Through his efforts and good judgement the North Carolina State Elks Association was reorganized. He was able to arrange to have the key members from each Lodge in the State, to attend the 1939 Fall Convention in Charlotte, with a purpose of having a reason and goal, for having a State Association. This, he accomplished.

He was appointed District Deputy Grand Exalted Ruler - East in 1941 - 1942. During this year he had a great influence in instituting the Greenville Lodge No. 1645 and reinstituting Kinston Lodge No. 740 and Wilson Lodge No. 840.

In 1945 the State Association Project Committee had purchased the Boys Camp near Hendersonville. Raymond Fuson served on the Board of Governors for the Boys Camp and was one of the first to plan and and arrange the operation of it.

Brother Fuson was elected the State President of the Exalted Rulers Association in 1952 - 1954.

He was elected State President of the North Carolina State Elks Association in 1954 - 1955.

At the convention in May of 1977, he was awarded the "Distinguished Service Award" for his unselfishness, loyalty and dedicated service.

At his death in 1977 he was 87 years of age, and still serving as the secretary of New Bern Lodge No. 764.

A. J. (JIM) CRANE RETIRES AS STATE ASSOCIATION SECRETARY

In the spring of 1982, Brother Jim Crane of Kinston Lodge No. 740, resigned as secretary of the North Carolina State Elks Association because of health. Jim and his lovely wife Ruby had not missed a State or National Convention while he maintained the office of secretary. President Bill Allen said in his farewell speech "One of my hardest duties this year was to except the resignation of our State Secretary, Jim Crane. His service to our association has been truly appreciated by all of us and we wish Jim and Ruby well for many years to come".

Jim was initiated into the Kinston Lodge No. 740 in 1942. Kinston Lodge on October 24, 1941 was reinstituted.

Jim served in the United States Army from 1942 to 1945.

After serving in the service, he progressed through the chairs of Kinston Lodge No. 740 and in 1960 - 1961 he was elected Exalted Ruler. He served on the Board of Trustees of the Lodge for three years, 1961 - 1964.

The members of Kinston Lodge No. 740 awarded him the "Elk of the Year Award" in 1964 for his loyal and devoted work for the Lodge.

His interest and work further expanded in 1963 when he was appointed District Deputy Grand Exalted Ruler - East; 1963 - 1964.

In 1965 - 1966 he was elected Vice President at Large in the North Carolina State Elks Association and its President in 1966 - 1967.

Appointed to the first "Distinguished Service Award" committee in 1966. Grand Lodge Americanism Committee in 1968 - 1971.

At the annual convention in 1966, in Durham, Brother A. J. Crane was elected to a full term as Secretary of the North Carolina State Elks Association. He had been appointed the previous year by President Thompson to replace secretary Arthur A. Ruffin who had resigned.

The members of Kinston Lodge No. 740 made him an Honorary Life Member of the Lodge in 1971.

The State Association presented him with the "Distinguished Service Award" in 1977.

RESOLUTION

WHEREAS, the 1981 State Elks fall convention was convened in Hickory on October 29, and the absence of Brother A. J. Crane, its secretary, was noted; and

WHEREAS, the delegates were informed that his absence, the first in more than twenty years, was occasioned by advice from his doctor because of a temporary indisposition and the travel distance involved.

NOW, THEREFORE, BE IT RESOLVED:

That the Association records the absence of Secretary A. J. Crane with regrets. Appreciation for his heretofore unbroken record of faithful attendence and service is acknowledged, with sincere good wishes for a quick, full and complete restoration to usual and continued good health.

Jim resigned as State Secretary, January 1, 1982.
Many years of dedicated service to the North Carolina
State Association continued and his attendance at the
State Convention in Winston-Salem 1995 was very memorable.

Arthur James "Jim" Crane, 90, died July 10, 1997.

Jim has passed into the light which is beyound the valley of the shadow of death. The places that have known him shall know him no more; but his virtues are written upon the tablets of love and memory. AMEN AND AMEN.

A MEMORIAL TO GEORGE T. SKINNER, STATE ASSOCIATION CHAPLAIN

George T. Skinner of Kinston Lodge No. 740, retired as Chaplain of the North Carolina State Elks Association during the Lodge year, 1983 - 1984. He had served as Chaplain for ten years, 1973 to 1983.

He was the first full-time Exalted Ruler of Kinston Lodge No. 740. Served the year of 1942-1943.

In 1945, he was a member of the first Boys Camp formation committee. Served on the Boys Camp Board of Governors in 1946-1950.

Appointed District Deputy Grand Exalted Ruler - East in 1947-1948.

Elected President of the North Carolina State Elks Association the fiscal year of 1951-1952.

Had several State assignments on committees over the years 1949-1960.

Members of Kinston Lodge presented him with a Honorary Life Membership in Kinston Lodge No. 740, in 1960.

The State Association presented him with the "Distinguished Service Award" in 1978.

George T. Skinner died June 30, 1987 at the age of 96.

At the Annual Meeting of the State Association in Winston-Salem on May 18, 1984 the following resolution was passed:

WHEREAS, Brother George T. Skinner, a devoted and loyal member of the Kinston Elks Lodge, resigned as Chaplain of the State Elks Association during the lodge year; and

WHEREAS, Brother George T. Skinner was one of the few individuals who brought about the reactivation of the North Carolina State Elks Association in the early forties, and has contributed so much to the growth and good of the Order serving in the chair offices in his lodge, District Deputy, President of the State Elks Association and as Chaplain; and

WHEREAS, George T. Skinner, has attended nearly all, if not all, district clinics and state conventions since the reactivation of the Association, and has devoted his talent and service of such magnitude that it enhanced the growth, respect and esteem of the Order, which is praiseworthy.

NOW, THEREFORE, BE IT RESOLVED:

That the delegates to this convention express their grateful thanks and appreciation to George T. Skinner for his faithful and devoted service, and wish him many years of peace, contentment and happiness in his chosen retirement, with full knowledge of the respect and love that his brothers have for him.

KERMIT R. HOFFMAN WAS INITIATED INTO THE ASHEVILLE LODGE #1401 (NOW #608) APRIL 1946, 54 YEARS AN ELK OF OUTSTANDING ACCOMPLISHMENTS. THERE ARE VERY FEW MEN THAT CAN COUNT THEMSELVES SO FORTUNATE IN SERVING THEIR COMMUNITY.

KERMIT WAS WORKING WITH THE PUBLIC SERVICE COMPANY IN ASHEVILLE WHEN HE MARRIED PAT REYNOLDS. HE WAS IN THE ARMY PRIOR TO WORKING WITH PUBLIC SERVICE COMPANY. WHEN KERMIT AND PAT WERE TRANSFERRED TO GASTONIA, KERMIT TRANSFERRED HIS MEMBERSHIP IN ELKDOM TO THE GASTONIA LODGE #1634. KERMIT WAS SENIOR VICE PRESIDENT AND CORPORATE SECRETARY AND CONTINUED AS A CONSULTANT FOR FIVE YEARS AFTER RETIREMENT WITH THE PUBLIC SERVICE COMPANY AFTER 40 YEARS SERVICE. KERMIT WAS A MEMBER OF THE FIRST PRESBYTERIAN CHURCH AND PAST PRESIDENT OF THE GASTONIA KIWANIS CLUB ALONG WITH CONSIDERABLE WORK WITH SCOUT TROOP 213-ST. MICHAEL'S WHERE HE RECEIVED THE ST. GEORGE MEDAL IN SCOUTING. HE WAS ALSO ACTIVE IN THE UNITED WAY AND THE CHAMBER OF COMMERCE AND ANY OTHER COMMUNITY SERVICE THAT WAS BROUGHT TO HIS ATTENTION.

PAT AND KERMIT CELEBRATED THEIR 50TH WEDDING ANNIVERSARY IN 1996 WITH A PARTY GIVEN BY THEIR CHILDREN.

KERMIT BEGAN AN ACTIVE ROLL IN GASTONIA LODGE #1634 IN THE LATE 50'S. HE SERVED AS ESQUIRE, TWO YEARS AS LECTURING KNIGHT, TWO YEARS AS LEADING KNIGHT, AND WAS ELECTED EXALTED RULER IN 1960-1961. HE SERVED FIVE YEARS AS A TRUSTEE 1974-1979 AND WAS ELECTED TO A SECOND FIVE YEAR TERM AS TRUSTEE. AFTER SERVING ONE YEAR HE WAS ELECTED TO HIS FIRST TERM AS SECREATRY, A POSITION HE HELD FOR TWO YEARS. HE WAS AGAIN ELECTED TO THE TRUSTEES FOR THREE YEARS, 1982-1985. IN 1985 HE WAS AGAIN ELECTED SECRETARY, A POSITION HE HELD UNTIL HIS DEATH.

KERMIT HAS BEEN VERY ACTIVE IN THE WEST DISTRICT AND IN THE STATE ORGANIZATION. HE WAS APPOINTED DISTRICT DEPUTY GRAND EXALTED RULER WEST DISTRICT IN 1967-1968. HE WAS ELECTED VICE PRESIDENT AT LARGE IN 1972-1973 AND SERVED AS STATE PRESIDENT 1973-1974. HE WAS ELECTED STATE TREASURER IN 1980-1981. EVERYONE KNOWS KERMIT'S REPUTATION FOR HOLDING ONTO THE STATE'S DOLLARS.

IN 1986, THE GASTONIA LODGE #1634 RECOMMENDED KERMIT FOR THE #THAD EURE DISTINGUISHED SERVICE AWARD" FOR HIS DEDICATION AND SERVICE TO ELKDOM. KERMIT WAS ELECTED TO AN HONORY LIFE MEMBERSHIP BY THE GASTONIA LODGE #1634 IN 1993.

OVER THE YEARS KERMIT HAS BEEN A SUPPORTER OF THE NATIONAL FOUNDATION WITH FOUR PAID PARTICIPATING MEMBERSHIPS. HE HAS BEEN A SUPPORTER OF MOST EVERY CAUSE THE ELKS PROPOSE.

ROBERT S. MESSER, PDDGER AND LONG TIME FRIEND AND ELK BROTHER OF KERMIT HOFFMAN, PENNED A PORTION OF THE FOREGOING ON BEHALF OF PAT AND KERMIT IN 1996 CELEBRATING KERMIT'S "HAPPY 50TH ELKS ANNIVERSARY".

OUR BROTHER ELK, KERMIT ROY HOFFMAN, DIED JULY 7, 2000. HE IS SURVIVED BY WIFE, PATRICIA REYNOLDS HOFFMAN; SONS AND DAUGHTERS-IN-LAW, JOSEPH KERMIT AND KAREN E. HOFFMAN, GEORGE ANTHONY AND JANET S. HOFFMAN, WILLIAM ALLEN HOFFMAN, JAMES LAWRENCE HOFFMAN, KENNETH LEE HOFFMAN, SON-IN-LAW TIMOTHY REILLY; 20 GRANDCHILDREN; THREE GREAT GRANDCHILDREN.

HE HAS PASSED INTO THE LIGHT WHICH IS BEYOND THE VALLEY OF THE SHADOW OF DEATH. THE PLACES THAT HAVE KNOWN HIM SHALL KNOW HIM NO MORE; BUT HIS VIRTUES ARE WRITTEN UPON THE TABLETS OF LOVE AND MEMORY. AMEN AND AMEN.

WILLIAM ERNEST BELL-PAST STATE PRESIDENT-GRAND LODGE OFFICER

ERNEST DIED MARCH 30, 2002. HE WAS BORN IN CHESTER, PENN., JUNE 1, 1920. ERNEST ATTENDED DURHAM HIGH SCHOOL AND SERVED IN WORLD WAR 11 AND THE KOREAN WAR AS A U.S. MARINE. HE WAS HONORABLY DISCHARGED AFTER EIGHT YEARS OF SERVICE. HE ALSO SERVED AS A BOY SCOUT LEADER OF THE OCCONEECHEE COUNCIL OF HILLSBOROUGH.

ERNEST AND HILDA WERE MARRIED 57 YEARS AND HAVE ONE DAUGHTER, SUSAN, AND TWO SONS, DOUG AND SAMMY. THEY HAVE FIVE GRANDCHILDREN,

ERNEST ACHIEVED 32 DEGREE MASON AT THE EAGLE LODGE OF HILLSBOROUGH AND WAS A LIFE LONG MEMBER OF PLEASANT GREEN UNITED METHODIST CHURCH.

ERNEST WAS INITIATED INTO THE DURHAM LODGE SEPTEMBER 25, 1961 AND SIX MONTHS LATER APPOINTED LODGE ESQUIRE. HE WAS THEN ELECTED TO ALL CHAIRS AND BECAME EXALTED RULER IN 1966. DURING THIS PERIOD HE WAS CHAIRMAN OF THE LODGE YOUTH ACTIVITY PROGRAM AND RECEIVED SEVERAL AWARDS FROM THE STATE ELKS ASSOCIATION. IN 1969 HE WAS APPOINTED STATE YOUTH ACTIVITY CHAIRMAN AND HELD THIS POSITION UNTIL 1974. HE WAS ELECTED TO THE BOARD OF GOVERNORS OF THE ELKS BOYS CAMP IN 1971 AND SERVED ON THIS COMMITTEE FOR SEVENTEEN YEARS.

HE WAS APPOINTED DISTRICT DEPUTY GRAND EXALTED RULER IN 1968 BY THE HONORABLE ED MC CABE, GRAND EXALTED RULER.

HE BECAME PRESIDENT OF THE NORTH CAROLINA STATE ASSOCIATION IN 1976. HE WAS APPOINTED TO THE GRAND LODGE YOUTH ACTIVITY COMMITTEE IN 1981 AND 5 YEARS LATER AT THE GRAND LODGE SESSION IN SEATTLE HE WAS APPOINTED CHAIRMAN OF THE COMMITTEE. ERNEST RECEIVED THE NORTH CAROLINA DISTINGUISHED SERVICE AWARD IN 1979 AND SERVED AS SPECIAL DEPUTY GRAND EXALTED RULER FROM 1987-1994. IN 1993 HE WAS GRAND INNER GUARD AND THE DURHAM LODGE #568 VOTED HIM AN HONORARY LIFE MEMBERSHIP.

ERNEST WAS CERTAINLY A MAN OF GREAT COURAGE AND DEDICATION AS EVIDENCED BY HIS CONTINUED SUPPORT AND ATTENDANCE IN THE EVENTS IN ELKDOM, BOTH LOCALLY AND NATIONALLY. THIS DURING A TIME WHEN HE WAS IN SERVERE FAILING HEALTH. WHEN HIS NAME WAS CALLED IN THE ATTENDANCE CHECK AT THE STATE CONVENTIONS HIS ANSWER WAS ALWAYS, "GOOD TO BE HERE".

BYLAWS

ARTICLE I

MEMBERSHIP

- SEC. 1. Every lodge in the state of North Carolina in good standing with the Grand Lodge of the Benevolent and Protective Order of Elks of the United States of America shall be eligible for membership in the North Carolina State Elks Association, Inc., upon complying with the by-laws of said Association.
- SEC. 2. Every member lodge shall be entitled to representation at all meetings of the Association, whether regular or special. Each Lodge must be in good standing as of the date of the Associations meeting. Each lodge shall be entitled to one (1) vote for each fifty (50) members or major fraction thereof, as shown by its latest Annual report to the Grand Lodge.

ARTICLE II

OFFICERS

- SEC. 1. The officers of the Association shall be a President, President Elect, four (4) District Vice Presidents, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Chaplain, Tiler, Organist and four (4) Trustees, one from each district. These officers shall be elected from those members who have served as exalted ruler of their respective lodges, or some other subordinate lodge of the Benevolent and Protective Order of Elks.
- SEC. 2. All officers, except the Tiler, Organist and Trustees, shall be elected annually and shall hold office for one year. The office of the President and President Elect shall rotate from district to district at each annual election. The President shall be elected in 1982 from the east district and years to follow by rotating from the east district to the west central district, to the east central district to the west district, and back to the east district on a four (4) year rotation thereafter and in that order. The President Elect shall be elected in 1982 from the west central district and rotate therefrom in the same order as the President. The Trustees shall hold office for four (4) years, with one Trustee being elected at each annual meeting with the said Trustee coming from the district of the retiring Trustee. The Tiler and Organist shall be appointed by the President and serve at the President's pleasure.
- SEC. 3. For the purpose of electing district Vice Presidents and Trustees, the state of North Carolina shall be divided into four (4) districts to be designated as North Carolina East, North Carolina East Central, North Carolina West Central and North Carolina West. The said districts shall be the same as designated by the Grand Lodge. A Vice President must reside in the district he represents and be a resident at the time of his election.
- SEC. 3A. For the purpose of nominating officers for the North Carolina State Elks Association, Inc., each district at the district deputy's clinic held in January of each year pursuant to the Grand Lodge Rules and Statutes, shall nominate from each respective district, a Vice President, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Chaplain, and a President Elect and Trustee when it's said district's turn for President Elect or Trustee from said district.
- SEC. 4. At the spring 1983 district deputy clinic each district must establish rules for the nomination of the officers as set forth above, however, in adopting procedure for the nomination of the officers from each district, the lodges shall be entitled to vote as set forth in Article I Sec. 2. above. A simple majority is necessary for the adoption of officers. The Vice President of each district shall preside at the meeting or meetings in his district for the purpose above. In the absence of the Vice President at such meetings, the Vice President shall designate a former Vice President from his district to preside. Upon the Vice President to designate a former Vice President at such meetings, the state President shall designate a former Vice President of the district to conduct the meeting or meetings.
- SEC. 4A. Nothing herein contained shall prohibit nominations from the floor; provided, however, the person nominated shall comply with the residency requirements above set forth.

- SEC. 5. <u>President:</u> The President shall be the Chief Executive Officer of the Association. He shall preside at all meetings of the Association, decide all questions of order, appoint all committees not otherwise provided for, perform all other duties as may be required by an action of the Association, and such duties as are customarily performed by the Chief Executive Officer of an Association. It shall be his duty to make such official visits to the lodges of the Association, as the interests of the Association require, and to attend such district meetings, as he deems necessary for the good of the Association.
- SEC. 5A <u>Vacancies</u>: Should a vacancy in office occur between annual meetings, the vacancy may be filled by the State President, with the approval of the Advisory Board, except as otherwise provided by these bylaws.
- SEC. 6. <u>President Elect</u>: The President Elect, having been elected by the Association shall succeed to the Presidency in the year following this election and shall assist the President in the performances of his duties, shall preside at meetings of the Association in the absence of the President, shall serve as coordinator for all permanent, special or consolidated committee activities, and shall succeed to the office as acting President of the Association in the event of the death, resignation or permanent disability of the President. If such a vacancy should occur, the advisory committee shall meet and elect an interim President Elect to fill the remaining term. The President Elect shall prepare a proposed State Association program for the year and make all Committee assignments prior to March 31, these assignments and program shall be sent to the State Sponsor, State Secretary, Advisory Board and Trustees of the Association by April 1, for review.
- SEC. 7. District Vice President: It shall be the duty of each District Vice President to visit all of the lodges in his district at least once during the term of his office, promote interlodge visits and ritualistic contests among the lodges in his district and attend their District and State Ritual Clinics. He shall promote all the programs of the State Association and perform such duties as may be requested or delegated by the President and assisting him in the discharge of any duty existing within the district. In cooperation with the district deputy Grand Exalted Ruler, the Vice President shall hold at least a meeting in January of each year for representatives in his district. He shall conduct the meeting for the nomination of officers as herein, above, set forth in addition each Vice President, shall be the Hoop Shoot Chairman in his district and be a member of the State Hoop Shoot Committee. He shall conduct his district's Hoop Shoot Contest. He may appoint members in his district to serve with him in conducting and promoting the said contest.
- SEC. 8. Secretary: The Secretary shall attend all meetings of the Association, keep true record of the proceedings, preserve all books and documents, receive all moneys paid into the Association, and promptly pay same over to the Treasurer, taking his receipt therefor, and perform such other duties as are required of him. He shall, before assuming the duties of his office execute and deliver to the Board of Trustees, such bonds as may be required by them, the expense of such bond to be paid by the Association.
- SEC. 8A. Assistant Secretary: The Assistant Secretary will assist the Secretary in all duties of office as outlined in Section 8 above and act in his absence due to death, disability or resignation until the next annual election.
- SEC. 9. Treasurer: The Treasurer shall attend all meetings of the Association and receive and have custody of all the moneys belonging to the Association. He shall pay the money of the Association only upon proper warrant drawn by the Secretary, countersigned by the President, and approved by a majority of the Board of Trustees. He shall make an annual fiscal report to be presented to the Secretary for distribution to member lodges, to present said report to the advisory board at each Spring convention and to present a budget to the advisory board for the next fiscal year. He shall, before assuming the duties of his office, execute and deliver to the Board of Trustees a bond as may be required by the Trustees, the expense of said bond to be paid by the Association.
- SEC. 9A. <u>Assistant Treasurer</u>: The Assistant Treasurer will assist the Treasurer in all duties of office as outlined in Section 9 above and act in his absence due to death, disability or resignation until the next annual election.
- SEC. 10. Chaplain: The Chaplain shall attend all meeting of the Association and perform such duties as are customary to be performed by such officer.
- SEC. 11. <u>Tiler</u>: The Tiler shall have charge of the doors of the hall in which the meetings are held and shall perform the duties usually incidental to the office of the Tiler in the lodge.

- SEC. 12. Trustees: The Chairman of the Board of Trustees shall be from the same district as the State President. The Secretary of the Association shall be the recording Secretary for the Board of Trustees. The Board shall hold four (4) regular meetings a year at a time and place determined by the Chairman. In addition the chairman may call a special meeting when deemed necessary. The Board of Trustees shall, during the interim between meetings of the Association, take charge of its property and the direction of its affairs. During such interim, it shall be the governing body of the Association and it shall take such action as may be necessary to promote its objects and protect its interests. It shall have control of the finances of the Association, and shall recommend ways and means of raising funds to defray the expenses of the Association. It shall prepare and submit at the annual meeting, a budget for the ensuing year. The Lodge entertaining the State Association must submit a program of entertainment to the Board of Trustees for approval, and the Board shall have the power to limit the amount of money to be spent by the lodge for entertainment. The Board of Trustees shall have full charge and control of each convention held by the Association, and shall make rules and regulations for the conduct of the convention and the members of the order attending same. The Board of Trustees shall pass upon all bills for accounts to be paid from the funds of the Association. The President and the President Elect shall be exofficio members of the Board of Trustees, and shall be entitled to vote as such. Four (4) members shall constitute a quorum. The Vice Chairman shall come from the same District as the President Elect. The Association owns a camp in Henderson County North Carolina, which shall be known as the North Carolina Elks Camp. The Trustees through an "Elks Camp Architectural Committee" shall administer the camp property.
- SEC. 13. The officers elect shall be installed on the last day of the annual meeting. The President shall designate the installing officers, and they shall prepare to perform the ceremony necessary.
- SEC. 14. Reports: The President shall make a report at the annual and fall meetings of the Association of his activities and the work in progress of the Association under his administration. The President Elect and the District Vice Presidents shall report to the President, and upon his request, give an oral report at the meeting of the Association. The Secretary shall submit a report of his office at each meeting of the Association. The Treasurer shall submit a report of the financial condition of the Association at each session thereof. The President may require reports of committee chairman and others as he deems necessary.
- SEC. 15. The President, President Elect, District Vice Presidents, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Chaplain, Organist, Tiler and the Board of Trustees shall be given an allowance for reimbursement for travel, postage, supplies, and other necessary expenses in the conduct of the Association's business and the attending of the meetings. The allowance shall be set by the Board of Trustees in its proposed annual budget and approved by the Association at its annual meeting.
- SEC. 16. The President, President Elect, Secretary, and Treasurer shall attend the National Convention. For attending the National Convention the Board of Trustees shall designate an amount for each officer to assist him in attending the Grand Lodge convention. The amount of the allowance shall be set by the Board of Trustees in its proposed annual budget and approved by the Association at its annual meeting. The allowance made to the said officers shall not exceed the allowance made to the District Deputy Grand Exalted Ruler in attending Grand Lodge sessions as set forth in Section, 4.240 of the Grand Lodge statutes.
 - SEC. 17. The salaries of officers, if any, shall be recommended by the Trustees and approved by the Association.
- SEC. 18. All officers elected under the provisions of these by-laws or who were elected under the provisions of the North Carolina Elks Association shall hold office until their successors have been duly elected and qualified.
- Sec. 19. <u>Conflict of Interest</u> No State Association Officer shall simultaneously occupy another position in the Association, when the relationship between the Association Office held and the other position occupied is such to give rise to an apparent, potential or actual Conflict of interest. No officer may simultaneously hold more than one office of the association either elected or appointed.

ARTICLE III

NORTH CAROLINA ELKS' CAMP

- Sec. 1. The North Carolina Elks Association owns a camp in Henderson County, North Carolina, which shall be known as the North Carolina Elks Camp. The camp property shall be administered by an "Architectural Committee" recommended by the District Vice Presidents and State President and when elected by the State Association, shall operate under the supervision of the State Association Trustees as set forth herein
- Sec. 2. The Architectural Committee shall have total responsibility for general maintenance and capitol improvements of the camp property. It shall look for ways to upgrade and promote the camp facilities to insure that our "State Project" is the best that it can be. The Architectural Committee shall consist of four (4) members, one for each district. In 2000, four members shall be elected to the committee, one for each of one, two, three and four year terms. The four-year member shall come from the same district as the immediate Past State President. The senior member shall become Committee Chairman on his final year on the committee making him the Chairman the same year as the Trustee Chairman. The State Association President, President Elect and the Chairman of the Camp Executive Committee shall be exofficio members of the committee, and shall be entitled to vote as such.
- Sec. 3. The Board of Governors and Board of Directors shall be responsible for operating the camp during the "Encampment Sessions". Each member of the Board shall be entitled to a vote providing that they are present at the meeting of the Board; except, however, a Board member may nominate in writing any member of their Lodge to be a proxy at the meeting of the said Boards. The written proxy must be presented to the person presiding at the meeting of the Boards.
- Sec. 4. The Board of Governors and Board of Directors as hereinafter set forth, shall meet annually at the camp on the third Sunday in September. The president of the Association may call a special meeting of the Boards at any time by giving not less that ten (10) days written Notice to each member of the Boards.
- Sec. 5. The responsibility for the actual operation of the North Carolina Elks Camp during the camping sessions is delegated to the Board of Governors and Board of Directors. The Board of Governors shall consist of sixteen (16) members, four from each district. One member from each district shall be elected annually and serve a four year term. The Association President, Assistant Treasurer and Assistant Secretary shall be exofficio members of the board. In the event of a vacancy, the President of the Association shall fill the vacancy by an interim appointment from the district where the vacancy occurred. The appointment shall be for the remainder of the Association year. The nominee shall stand for election at the next annual meeting of the Association. The Board of Directors shall consist of the Exalted Rulers of each lodge that is a member of the North Carolina State Elks Association. An Exalted Ruler, if he so chooses may appoint a member of his lodge to fill his place as a member of the Board of Directors providing the chairman of the Elks Camp Executive Committee is notified in writing of the appointment. All members of the Board of Governors and Board of Directors shall continue to serve until their successors shall have been elected or appointed and qualified. Eight members from each Board along with the Executive Committee shall constitute a quorum for any meeting. The Board of Governors and Board of Directors shall meet at annual meetings of the Association and all matters of business shall be decided by a majority vote of those present.
- Sec. 6. At the meeting of the Board of Governors and Board of Directors to be held on the third Sunday in September, the Board of Governors from its membership shall elect a member to its Executive Committee. The Executive Committee shall consist of four (4) members, one from each district. The newly elected member shall come from the same District as the immediate past State President. Members of the Executive Committee shall also serve as Secretary, Treasurer, Vice Chairman and Chairman of the Committee, with the newest member of the Executive Committee acting as Secretary. The Executive Committee members will progress in seniority, with the Chairman coming from the same district as Trustee Chairman. Members of the Executive Committee shall not be allowed to succeed themselves during the year after their term expires. The Executive Committee will operate the camping sessions and will carry out the policies established by the North Carolina Elks Association and the Boards of Governors and Directors. The Executive Committee must approve all bills and checks shall bear the signature of the Chairman or another member of the Executive Committee and the Camp Director. At the annual meeting of the Boards of Governors and Directors, a certified public accountant shall be named to audit the books of the camp at the conclusion of each session. The Association may order an additional audit of the encampment session if deemed appropriate. The Camp Director will pass all bills to the Executive Committee not later than the 5th day of the month following their occurrence. The Executive Committee and the Camp Director will be bonded in the amount of \$50,000.00.
- Sec. 7. The Board of Governors and Board of Directors shall meet in the spring at a time and place designated by the State President. At this meeting, a proposed budget shall be adopted and passed to the State Trustees for approval. The budget must then be approved by the Association at its annual meeting. The President of the State Association may call a special meeting of the Executive Committee or Boards of Governors and Directors at any time by giving not less than ten (10) days written notice to each member.

October 27, 2002

- Sec. 8. After the operational policies are established and the budget is adopted by the Boards of Governors and Directors and the State Association, no change in said policies may be made except by a two-thirds (2/3) majority of the Boards of Governors and Directors; provided however, that a two-thirds (2/3) majority is required for any such change. The two-thirds majority shall be computed on the combined voting strength of members present at the joint meeting of both boards called for the purpose of considering said changes.
- Sec. 9. The Executive Committee shall make a final report of camp operations to the Boards of Governors and Directors at the September meeting and to the Association at the next annual meeting. The Boards may also submit any recommendations for future encampments.
- Sec. 10. The Camp Architectural Committee is charged with the responsibility of making recommendations to the State Association Trustees for major improvements to the camp. All Proposed improvements must be set fourth in writing, containing a detailed description of what is to be done along with contractors and cost estimates. The State Association must approve all major improvements.
- Sec. 11. No Mortgage shall be placed on and property of the Association, or money borrowed in the name of the North Carolina Elks Camp or any conveyance of real estate whatsoever without the recommendation of the Board of Trustees and approved by the State Association. No sale of personal property of the Association shall be made with out the approval of the Board of Trustees. The Grand Trustees of the Order of Elks must subsequently approve any transactions of this type in accordance with Section 16.050 of the Statutes of the Order.

ARTICLE IV

MEETINGS

SEC. 1. This Association shall hold two regular meetings each year. The Spring meeting shall be designated as the annual convention meeting at which officers are elected and all other business transacted. The fall meeting shall be a regular meeting and all business may be transacted at such meeting. The place and time of the annual convention meeting and the fall meeting, shall be determined by the delegates in convention, or the Board of Trustees may be authorized by the delegates to determine the time and place, or both. Notice of the time and place of the annual meetings shall be given to the member lodges not less than sixty (60) day before the first day of said meeting, except where an emergency causes a change of place or time within such period, and in such event, notice of the change must be given promptly, but in no event shall a meeting be held on less than twenty (20) days notice.

The Trustee from the district hosting the convention will be responsible for the convention.

- SEC. 2. Special meetings of the Association may be called by the Board of Trustees upon not less than twenty (20) days notice in writing to the member lodge.
 - SEC. 3. Delegates representing not less than fifteen (15) lodges shall constitute a quorum.
- SEC. 4. Any activity involving, or proposed to involve the North Carolina Sate Elks Association must be brought up at a regular meeting of the Sate Association for discussion and must be voted on favorably before any action is permitted to be taken. Any committee or proposed interlodge organization desiring to take any statewide action with the lodges, or members of the State Association, must have the sanction of the North Carolina State Elks Association meeting in regular session before proceeding with the planned activity.
- SEC. 5. The Past Exalted Rulers Association is an activity authorized, sponsored by and a part of the North Carolina State Elks Association, Inc., and its acts, as well as the acts of its officers and agents, are within the jurisdiction of the Sate Association and so recognized.

ARTICLE V

REVENUE

SEC. 1. Each member lodge shall pay annually to the Association, three dollars (\$3.00) for each member of its rolls on March 31st next preceding the annual meeting. Member lodges must pay Association dues prior to the convening of the annual convention so that delegates may be seated and entitled to participate in the proceedings. Fifty, (50) cents of said fund shall be a subscription fee allocated to financing the official publication of a state newspaper; however, if funds from other sources are available for said purpose, any excess from this fund shall be deposited to the general fund as set forth in Sec. 2. of this Article V.

SEC. 2. The per capita dues of three dollars (\$3.00) per member shall be allocated as follows:

(a) fifty (50) cents for the financing of the official newspaper for the organization; except, however, any excess as set forth in (b) Sec. 1. of this article shall become a part of the general fund and administered as set forth in Sec. (b) here under.

(b) two dollars and fifty cents (\$2.50) of said per capita dues shall be deposited to the credit of the general fund and used exclusively to defray the budgetary expenses of conducting the affairs and business of the Association. All accumulated moneys heretofore received from a portion of the per capita dues and carried as a savings fund shall be frozen and earmarked as a continuing fund to which contributions may be made from time to time, and all income therefrom shall be budgeted annually for necessary capital improvements, and for any educational, recreational, or charitable program involving youth and all classes of deserving people which the Association itself directs.

SEC. 3. A new lodge instituted in the state shall be entitled to membership in the Association upon application, but shall not be assessed the annual charge until after the first annual meeting of the Association, following its induction.

ARTICLE VI COMMITTEES

SEC. 1. The President shall appoint, within thirty (30) days after each annual meeting, the following standing committees, each of which shall comprise not less than four (4) members nor more than the number of lodges in the state. The Camp Architectural Committee will be elected by the Association membership in accordance with Article III of the bylaws.

The President shall have the power to name special committees to have charge of different features of the annual meeting and such other special committees as are, in his opinion, necessary for the good of the Association. The District Deputies shall constitute the committee in the Grand Lodge. It shall be the duty of this committee to correlate and promote relations of the Association to the Grand Lodge, to report all resolutions and reports concerning amendments to the constitution of the Grand Lodge, and especially upon resolutions endorsed by this Association. The District Vice Presidents shall constitute a committee on interlodge relations. It shall be the duty of this committee to arrange for interlodge visits among the members of the subordinate lodges and to promote district meetings throughout the state.

SEC. 2. The committee on credentials shall examine the credentials of all delegates, alternate delegates, and others with privileges of delegates, and shall have power to pass upon the regularity of same. It shall make a preliminary report immediately after the opening of the annual meeting or of any special meeting.

- SEC. 3. The committee on auditing shall examine and audit the books of the Secretary and Treasurer, and shall submit annually to the Association its findings and recommendations it deems good for the Association. It shall report specifically whether the budget has been observed. The President may appoint an auditor to examine the accounts of the Secretary and Treasurer.
- SEC. 4. The committee on by-laws shall have referred to it and shall report to the Association all proposed amendments and proposed resolutions. The chairman of such committee shall be the Chief Law Officer of the Association and shall assist the President in the interpretation of its law.
- Sec. 5. The committee on Public Relations will provide guidance in the compiling and distributing to all news media activities of individual Elks, Lodges or the State Association as may be appropriate, and to collect and distribute to individual Lodges and Elks within the state, information which may be of interest to or helpful to the aims of Elkdom. Other duties may include training, media coverage of GER visits or help with State Newspaper.
- SEC. 6. The Fund Raising committee shall be responsible for the planning, development and implementation of all state fund raising activities. The committee shall provide detailed information to the State Trustees for its approval prior to any activity. The purpose of the fundraiser shall indicate where the proceeds of such activity shall be designated. Proceeds of fund raising efforts shall be processed in accordance with Article II section 8 of the by-laws.
- Sec. 7. The Camp Architectural Committee shall be responsible for the implementation any and all approved major or permanent improvements to the Elks Camp. One elected member from each district will serve on this committee, who will operate under the direction of the State Association Trustees

ARTICLE VII

RELATIONS WITH GRAND LODGE

- SEC. 1. The Secretary of the Association shall furnish from time to time to the Grand Exalted Ruler, Grand Secretary, and the Chairman of the Committee on State Associations of the Grand Lodge the following:
 - a) Copies of its by-laws, rules and regulations and amendments thereto.
 - b) copy of proceedings of each annual meeting including report of Treasurer.
 - c) all official circulars issued by it or under its authority.
 - d) list of lodges comprising the Association
 - e) list of officers immediately following each annual meeting, with correct post office address of each officer.
- SEC. 2. The Association shall observe strictly the provisions of the Constitution and Statues of the Grand Lodge relating to state Associations. No questions of political or sectarian character shall be introduced at a meeting of the Association, and no person shall directly or indirectly be endorsed for any public or Grand Lodge office. A resolution recommending action by the Grand Lodge shall be filed with the Grand Exalted Ruler and Grand Secretary, and shall not be given publicity until it has been submitted and approved by the Grand Lodge, and then only in accordance with the Laws of the Order.

ARTICLE VIII

ORDER OF BUSINESS

- SEC. 1. The order of business at all meetings of this Association shall be as follows, unless otherwise changed by a majority of the delegates:
 - 1. Call to order.
 - 2. Invocation.
 - 3. Tribute to the flag.
 - 4. Roll call of officers.
 - 5. Roll call of lodges.
 - 6. Report of committee on credentials.
 - 7. Reading of minutes of last meeting.
 - 8. Election of officers.
 - 9. Reports of officers.

- SEC. 2. In the event there is a dispute as to the rules and procedure, Robert's Rules of Procedure will be followed except when they are in direct conflict with these by-laws.

ARTICLE IX

AMENDMENTS

Sec. 1. Any proposed amendment or amendments to the By-Laws of the North Carolina State Elks Association, Inc., shall be presented in writing to the Chairman of the By-Laws Committee of the State Association. The Proposal shall be signed by the delegate or in case of submittal by a Lodge, the Secretary.

The Committee on By-Laws will review the proposal either by personal meetings, written or electronic means. Their recommendations and motions will be sent to each subordinate Lodge for their consideration. In no case shall the State Association vote on the amendment unless the Subordinate Lodges have had at least 30 days notification. It shall require a two-thirds (2/3) of the votes cast to adopt any amendment. Such amendments shall become effective when approved by the Committee on Judiciary of the Grand Lodge.

ARTICLE X

OFFICIAL NEWSPAPER

- SEC. 1. The Association shall publish a newspaper to be known as "North Carolina Elks News".
- SEC. 2. The President of the State Association shall name the editor who shall serve at the President's discretion. The President may name such other editors, business and circulation managers, and any other persons he deems necessary for the publication of said newspaper, however, the President may delegate this power to the editor.

SEC. 3. The Board of Trustees of the Association, with the advice of the editor, are authorized to make rules and regulations regarding the publication, advertisements contained therein, frequency of publication, and any other rules and regulations which in its discretion it deems necessary to carry out the publication and distribution of said newspaper to members of the Association.

ARTICLE XI

FISCAL YEAR

SEC. 1. The fiscal year of the North Carolina State Elks Association shall be from May 1--April 30.

ARTICLE XII

ADVISORY BOARD

Sec. 1. The past Presidents of the Association shall constitute the advisory board. The advisory board shall meet on Friday at a time predetermined at their previous meeting, prior to and in conjunction with the fall and spring conventions. The advisory board at the spring meeting of each year shall elect a Chairman and a Vice Chairman. The Secretary of the State Association shall serve, exofficio, as Secretary of the Advisory Board. The Advisory Board shall advise the President and other officers of the Association. It shall present to the general meeting a slate of officers to be voted on at the spring convention. The board is obligated to present the slate based on the reports of each district as provided by these by-laws and presented to the advisory board. The Chairman, or the Vice Chairman in the absence of the Chairman, may call special meetings of the Advisory Board when so requested by the President of the Association. The board may meet in person or by conference calls. The Board shall have no powers other than those of an advisory nature, and any actions taken by the board shall not be binding on the convention unless passed by the Association according to other provisions of these by-laws.

The members of the Advisory Board may make other rules and regulations to govern its meetings which are not inconsistent with these by-laws, and after written ten (10) day's notice to all living past state Presidents, provided, however, a quorum is present. A quorum shall consist of at least 40% of living past State Presidents. The Chairman and Vice Chairman will be sworn in as officers at the same time the other state officers receive their oaths of office. The President and President Elect of the Association shall be exofficio members of the Advisory Board without voting privileges. The Chairman of the Advisory Board, with the assistance of the President of the Association, may determine the guests, if any, to attend the Advisory Board dinners.

ARTICLE XIII

NORTH CARILINA STATE ELKS ASSOCIATION CHARITABLE TRUST

Sec 1. The North Carolina State Association Charitable Trust was established and incorporated in 1993 for the purpose of receiving and disbursing funds for charitable purposes by the N.C. State Elks Association.

Sec 2. The NCSEA Charitable Trust has its own by-laws and elects its own officers.

Amended October 26, 2001 at the fall meeting of the North Carolina State Elks Association, in New Bern North Carolina.

BYLAWS

OF

NORTH CAROLINA STATE ELKS ASSOCIATION

CHARITABLE TRUST

ARTICLE I

NAME, SEAL, AND OFFICE

- 1. NAME. The name of the Corporation is North Carolina State Elks Association Charitable Trust.
- 2. SEAL. The seal of the Corporation shall be circular in form and shall bear the word "SEAL" in the center and around the outer edge shall bear the initials N.C.S.E.A.C.T. The Board of Directors may change the form of the seal or the inscription thereon at their pleasure.
- 3. OFFICES. The principal office of the Corporation shall be the residence or office of the Secretary of the North Carolina State Elks Association, Inc.

ARTICLE II

MEMBERS AND MEETINGS OF MEMBERS

- 1. MEMBERSHIP. The members of the Corporation shall consist of every lodge that is a member of the North Carolina State Elks Association, Inc. and shall be entitled to vote as is set forth in Section 9 of this Article II.
- 2. RIGHTS OF LODGES. The right of a lodge to vote and all its rights, title, and interests in or to the Corporation shall cease on the termination of its membership in the North Carolina State Elks Association, Inc. No lodge shall be entitled to share in the distribution of the corporate assets upon the dissolution of the Corporation.
- 3. RESIGNATION OF LODGES. Any lodge may resign from the Corporation by delivering a written resignation to the President or Secretary of the Corporation.
- 4. ANNUAL MEETING: The annual meeting of the members of the Corporation shall be held in conjunction with and at the same place as the Spring Meeting of the North Carolina State Elks Association, Inc., and may be held prior to, during or at the end of the annual meeting of the said North Carolina State Elks Association, Inc.

- 5. NOTICE OF ANNUAL MEETINGS: The Secretary of the association in conjunction with the Secretary of the North Carolina State Elks Association, Inc. shall send to each member lodge of said association a notice that the annual meeting of the North Carolina State Elks Association Charitable Trust shall be held in conjunction with the meeting of the North Carolina State Elks Association, Inc. by not less than twenty (20) nor more than fifty (50) days before the meeting.
- 6. SPECIAL MEETINGS: Special meetings of the members, other than those regulated by statute, may be called at any time by the President or Vice President or by two (2) Directors and must be called by the President or Secretary upon receipt of the written request of one-third (1/3) of the subordinate lodges which make up the North Carolina State Elks Association, Inc.
- 7. NOTICE OF SPECIAL MEETINGS. Notice of a special meeting stating the time, place and purpose or purposes therein shall be sent by mail to each subordinate lodge of the North Carolina State Elks Association, Inc., not less than ten (10) nor more than forty (40) days before such meeting.
- 8. QUORUM. The quorum shall consist of delegates representing not less than fifteen (15) lodges from the North Carolina State Elks Association, Inc.
- 9. VOTING. At every meeting of the Corporation, the delegates from each lodge shall be entitled to vote. Each lodge shall be entitled to one (1) delegate for each fifty (50) members or major fraction thereof as shown by the latest annual report to the grand lodge of the Benevolent and Protective Order of Elks.
- 10. REMOVAL OF DIRECTORS OR OFFICERS. Any director or officer may be removed form office by the affirmative vote of two-thirds (2/3) of the delegates at any regular or special meeting called for that purpose, for conduct detrimental to the interest of this Corporation, for lack of sympathy with its objectives, or for refusing to render reasonable assistance in carrying out its purposes. Any such officer or director proposed to be removed shall be entitled to at least five (5) days notice in writing by mail of the meeting at which said removal is to be voted upon and shall be entitled to appear before and be heard at such meeting.
- 11. COMPENSATION AND EXPENSES. Directors and officers shall not be entitled to receive any compensation for their services, but by resolution of the Board of Directors, the directors and officers may be reimbursed for reasonable expenses in connection with the performance of their duties and attendance at the meetings.

ARTICLE III

DIRECTORS

- 1. ELECTION. The business and property of the Corporation shall be managed and controlled by the Board of Directors, who shall be elected annually at the annual meeting of the members or until the election and qualification of their respective successors, except as hereinafter provided for filling vacancies. The directors must be members of the Corporation and shall be chosen by ballot at the annual meeting of the Corporation by the delegates representing the lodges as is hereinabove set forth.
- 2. NUMBER. The number of directors of the Corporation shall be seventeen (17). Four (4) directors from each of the four (4) districts of the North Carolina State Elks Association, Inc. and the President of said association, ex officio, shall be a member of the Board.

At the January 2000 District Deputy Clinic, each district will nominate four (4) directors, one (1) for a four (4) year term, one (1) for a three (3) year term, one (1) for a two (2) year term and one (1) for a one (1) year term. In subsequent years in January each district will nominate a four (4) year director.

Directors will be installed at the business session at the Annual Spring Convention of the North Carolina State Elks Association during the meting of the North Carolina State Elks Charitable Trust.

- 3. RESIGNATION. Any director may resign at any time by giving written notice of such resignation to the Board of Directors.
- 4. VACANCIES: Any vacancy on the Board of Directors occurring during the year, may be filled for the unexpired portion of the term by the directors then serving, although less then a quorum, by affirmative vote of the majority thereof. Any directors so elected by the Board of Directors shall hold office until the next succeeding annual meeting of the members of the Corporation or until the election and qualification of successors.
- 5. ANNUAL MEETINGS: Immediately after each annual election, the newly elected directors may meet forthwith at the site of the annual meeting for the purpose of organization, the election of officers and the transaction of other business, and if a quorum of the directors be then present, no prior notice of such meeting shall be required to be given. The place and time of such first

meeting may, however, be fixed by written consent of the directors.

- 6. SPECIAL MEETINGS: Special meetings of the Board of Directors may be called by the President or Vice President and must be called by either of them on written request of any three (3) members of the Board.
- 7. NOTICE OF MEETINGS: Notice of all directors meetings, except as herein otherwise provided, shall be given by mailing the same at least three (3) days or by faxing the same at least one (1) day prior to the meeting to the usual residence or business address of the director, but such notice may be waived. Regular meetings of the Board of Directors may be held without notice at such time and such place as determined by the Board. Any business may be transacted in any director's meeting.
- 8. CHAIRMAN: At all meetings of the Board of Directors, the President or Vice President, or in the absence of a Chairman chosen by the Directors present, shall preside.
- 9. QUORUM: At all meetings of the Board of Directors, a majority of the Directors shall be necessary and sufficient to constitute a quorum for the transaction of business and the act of a majority of the Directors present at any meeting at which there is a quorum present, a majority of those present may adjourn the meeting from time to time without further notice to any absent director, and may take such other and further action as is provided by these Bylaws.
- 10. COMPENSATION: Directors may not receive any compensation for their services as such, but by resolution of the Board, they may be allowed reasonable expenses incurred in the performance of their duties or in attendance at special meetings.
- 11. POWERS. All the corporate powers, except as are otherwise provided for in these Bylaws and under the laws of the State pf North Carolina, shall be and are hereby vested and shall be exercised by the Board of Directors. The Board of Directors may by general resolution delegate committees of their own number or to officers of the Corporation, or to other members of the Corporation, such powers as they may see fit.
- 12. DUTIES. The Board of Directors shall present at the annual meeting of members a report, verified by the President and Treasurer or by a majority of the Directors, showing in appropriate detail the following: (a) the assets and liabilities, including the trust funds, of the Corporation as of the end of the fiscal year immediately preceding the annual meeting; (b) the principal changes

in assets and liabilities, including trust funds during the year immediately preceding the date of the report; (c) the revenue or receipts of the Corporation, both unrestricted and restricted to particular purposes, for the year immediately preceding the date of the report; and (d|) the expenses and disbursements of the Corporation, both general and restricted purposes, during the year immediately preceding the date of the report.

ARTICLE IV

OFFICERS

- 1. NUMBER: The officers of the Corporation shall be the President, Vice President, Secretary, Treasurer, and such other officers with such powers and duties not inconsistent with these Bylaws as may be appointed and determined by the Board of Directors. Any two (2) offices, except those of President, Vice President, and Secretary may be held by the same person.
- 2. ELECTION, TERM OF OFFICE AND QUALIFICATIONS. The President shall be elected annually by the Board of Directors from among their number and the other officers shall be elected annually by the Board of Directors from such persons as the Board of Directors may see fit, at the first meeting of the Board of Directors after the annual meeting of members of the Corporation.
- 3. VACANCIES. In case any office of the Corporation becomes vacant by death, resignation, retirement, disqualification or for any other cause, the majority of the directors then in office, although less than a quorum, may elect an officer to fill such vacancy, and the officer so elected shall hold office and serve until the first meeting of the Board of Directors after the annual meeting of members next succeeding and until election and qualification of his successor.
- 4. PRESIDENT: The President shall preside at all meetings of members and of the Board of Directors. He shall have and exercise general charge and supervision of the affairs of the Corporation and shall do and perform such other duties as may be assigned to him by the Board of Directors.
- 5. VICE PRESIDENT: At the request of the President, or in the event of his absence or disability, the Vice President shall perform the duties and possess and exercise the powers of the President; and to the extent authorized by law, the Vice President shall have such powers as the Board of Directors may determine, and shall perform such other duties as may be assigned to him by the Board of Directors.

- SECRETARY: The Secretary shall charge of such books, documents and papers as the Board of Directors may determine and shall have the custody of the corporate seal. He shall attend and keep the minutes of all the meetings of the Board of Directors and members of the Corporation. As long as the Secretary of the North Carolina State Elks Association, Inc., has a record containing all of the members of the Corporation and their addresses, Secretary of this Corporation shall not be required to maintain such a list of members and their addresses. The Secretary may sign with the President or shall Vice President, in name of and on behalf of the Corporation, any contracts or agreements authorized by the Board of Directors, and when so authorized or ordered by the Board of Directors, he may affix the Seal of the Corporation. shall, in general, perform all duties incident to the office of Secretary subject to the control of the Board of Directors, and shall do and perform such other duties as may be assigned to him by the Board of Directors. SECTION 8.
- 7. TREASURER: The Treasurer shall have custody of all funds, property and securities of the Corporation, subject to the regulations as may be imposed by the Board of Directors. He may be required to give bond for the faithful performance of his duties, in such sum and with such sureties as the Board of Directors may require. When necessary or proper, he may endorse on behalf of the Corporation for collection of checks, notes, and other obligations, and shall deposit the same to the credit of the Corporation at such banks or depositories as the Board of Directors may designate. shall sign all receipts and vouchers and, together with such other office or officers, if any, shall be designated by the Board of Directors, to sign all checks of the Corporation and bills of exchange and promissory notes issued by the Corporation, excepting cases where the signing and execution thereof shall be expressly designated by the Board of Directors or by these bylaws to some other officer or agent of the Corporation. He shall make such payments as may be necessary or proper to be made on behalf of the Corporation to be kept by him for the purpose full and accurate accounts of all monies and all obligations received and paid or incurred by him for or on account of the Corporation, and shall exhibit such books at such reasonable times as any director or member on application at the offices of the Corporation. He shall, in general, perform the duties incident tot he office of Treasurer, subject to the control of the Board of Directors.
- 8. SALARIES. No officer shall be paid any salary for the performance of his duties; however, the Board of Directors may authorize reimbursement for out-of-pocket expenses of an officer.

9. REMOVAL: Any officer who may be removed from office by the affirmative vote of two-thirds (2/3) of the directors at any regular or special meeting called for that purpose, for nonfeasance, malfeasance, or misfeasance, for conduct detrimental to the interests of the Corporation, for lack of sympathy with its objectives, or for refusal to render reasonable assistance in carrying out its purposes. Any officer proposed to be removed shall be entitled to at least five (5) days notice in writing by mail of the meting of the Board of Directors at which such removal is to be voted upon and shall be entitled to appear and be heard by the Board of Directors at such meeting.

ARTICLE V

AGENTS AND REPRESENTATIVES

The Board of Directors may appoint such agents and representatives of the Corporation with such powers and to perform such acts or duties on behalf of the Corporation as the Board of Directors may see fit, so far as may be consistent with these Bylaws, to the extent authorized or permitted by law.

ARTICLE VI

CONTRACTS

The Board of Directors, except as in these Bylaws otherwise provided, may authorize any officer or agent to enter into any contract or execute and deliver any instrument in the name and on behalf of the Corporation, and such authority may be general or confined to a specific instance. Unless so authorized by the Board of Directors, no officer, agent or employee shall have any power or authority to bind the Corporation by any contract or engagement, or to pledge its credit, or to render it liable pecuniary for any purpose or to any amount.

ARTICLE VII

The fiscal year of the Corporation shall be the same as the fiscal year for the North Carolina State Elks Association, Inc.

ARTICLE VIII

PROHIBITION AGAINST SHARING IN CORPORATE FUNDS OR EARNINGS

No member, director, officer, or employee of or member of a committee or a person connected with the Corporation or any other private individual shall receive at any time any earnings or profit

from the operations of the Corporation, provided that this shall not prevent the payment to any such person of such reasonable compensation for service rendered to or for the Corporation in effecting any of its purposes as shall be fixed by the Board of Directors; and no such person or persons shall be entitled to share in the distribution of any of the corporate assets upon the dissolution of the Corporation. All members of the Corporation shall be deemed to have expressly consented and agreed that upon dissolution or winding up of the affairs of the Corporation, whether voluntary or involuntary, the assets of the Corporation, after all debts have been satisfied, then remaining in the hands of the Board of Directors shall be distributed, transferred, conveyed, delivered and paid over, in such amounts as the Board of Directors may determine, or as may be determined by a court of competent jurisdiction upon application of the Board of Directors, exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(C)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

ARTICLE IX

INVESTMENTS

The Corporation shall have the right to retain any or all of any security or property acquired by it in whatever manner, and to invest and reinvest funds held by it, according to the judgment of the Board of Directors, without being restricted to the class of investments which a director is or may hereafter be permitted by law to make or any similar restriction; provided, however, no action shall be taken on behalf of the Corporation is such action is a prohibited transaction or would result in the denial of the tax exemption under Section 503 of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

ARTICLE X

AMENDMENTS

The Bylaws may be altered, amended or repealed at any meeting of the Corporation by a majority vote of the delegates, representing the subordinate lodges, provided that the proposed action is inserted in the notice of such meeting.

ARTICLE XI

EXEMPT ACTIVITIES

Notwithstanding any other provision of these Bylaws, no member, director, officer, employee, or representative of this Corporation shall take any action or carry on any activity by or on behalf of the Corporation not permitted to be taken or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

ARTICLE XII

GERALD AND LEA COATES ENDOWMENT FUND

- 1. There is established the Gerald and Lea Coates Endowment Fund, the corpus of which shall be invested in income producing property and securities, and the income of which shall be applied from time to time in such manner as the Directors of the North Carolina State Elks Association Charitable Trust may determine, for the furtherance of such of the charitable, educational, and benevolent activities of the Major Projects and Charities of the North Carolina State Elks Association, Inc., or otherwise, as said Directors may determine; provided, that money or property may be received by the Directors for other purposes than accumulation in the corpus of the Fund, if the donors thereof so direct, and within the general scope of the Fund.
- 2. The Endowment Fund shall be administered by the Board of Directors of the North Carolina State Elks Association Charitable Trust.
- 3. The North Carolina State Elks Association Charitable Trust Directors are hereby granted and given plenary powers to promote, develop, and administer the said Fund to accomplish its charitable, educational, and benevolent purposes; that said Directors be, and are authorized and empowered to received from any source any moneys, securities, or other property that may be properly transferred to them, in trust for the purposes for which the Fund is established; to invest the same in such safe securities and other property, to sell, transfer, and reinvest the same in such manner as shall best safeguard the Fund and assure the continuity of its income; and may either accumulate such moneys, securities, or other property as a part of the corpus, using only the income thereof, or may use all or part of such moneys, securities, or other property for purposes of distribution, in case the respective donors thereof may so direct, within the scope of the charitable,

educational, and benevolent purposes of the Fund. The said Directors shall report semi-annually to the North Carolina State Elks Association, Inc., their activities, the income and expenditures of the Fund during the past year and their prospective work and activities for the future. The disbursement of all moneys from the Endowment Fund shall be upon order of the Board of Directors, such order to be signed by the President and attested by the Secretary of such Board.
